The Committee discussed Patrick Long’s concept of using the BB&T wall on Main Street as a backdrop for the raised lettering “Welcome to Yadkinville.” Mr. Long reported that BB&T branch manager Mr. R.J. Speaks was in favor of the idea but that BB&T legal was looking for a hold harmless agreement to deal with the assignment of liability should an incident occur. The Committee discussed lettering and lighting possibilities. After further discussion, Mr. Chip Thomas made a motion to move forward with erecting a “Welcome to Yadkinville” sign at the BB&T site. Mr. Drum seconded the motion and it passed unanimously. Mr. Ong will contact Mr. Speaks to work out the liability issues.

Town Manager Christopher Ong stated that he has not yet heard back from Jason Joyce with DOT.

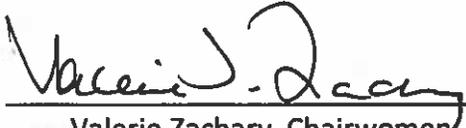
BUSINESS AWARD PUBLICITY SUBCOMMITTEE
