SPECIAL EVENTS ORDINANCE

Attorney Ben Harding presented the revised version of the special events ordinance. Chief Parks asked that Section A (application) under number 5 be amended to read as follows:

(a) Application: A written application for a Special Even Permit, including street closures, must be submitted to the Chief of Police at least sixty (60) days prior to the event: however, at the discretion of the Chief of Police the 60 day requirement can be waived by the Chief of Police.

Also, under 8 Application fee, it was the consensus of the board to add there shall be only one permit for recurring event with set dates within any one calendar year.

Commissioner Branon moved that Special Events Ordinance be adopted with recommended changes. Commissioner Norman seconded the motion and unanimously approved.

COURTHOUSE PARKING

Upon motion by Commissioner Norman the Board agreed to change the ordinance exempting emergency vehicle parking at the two spaces at corner of Elm and Jackson on official business. Commissioner Graham seconded the motion and unanimously approved.

Reported the Hoots Road project was completed. Also stated he had received no response from the Arts Council regarding the curbing and drainage problem on Elm Street.


COMMISSIONER COMMENTS


Board members expressed concerns over various issues in the Town. Commissioner Graham requested that the Town website be updated.
