The Town Board of Commissioners met in a "Special Called" Meeting on Friday, April 24, 2015 to discuss the 2015-2016 Fiscal Year Budget.

The purpose of this meeting was to review the 2015-16 Fiscal Year Draft Budget with the recommended changes by the Town Board of Commissioners from the budget workshop held April 10, 2015.

**CALL TO ORDER**

The meeting was called to order by Mayor Hubert Gregory at 12:11 p.m.

**INVOCATION**

Mayor Gregory offered the invocation.

**BUDGET AMENDMENT**

A budget amendment was presented to the Town Board for approval to transfer funds from Water/Sewer Operations Department to Water Plant Department-Capital Outlay for major repairs to concrete on the basins.

Commissioner Tony Hall made a motion to approve the budget amendment.

Commissioner Monta Davis-Oliver seconded the motion and passed unanimously.

Vote 5/0.

Chief Tim Parks requested permission from the Board of Commissioners to purchase four (4) body cams totaling \$4,000.00 for the Yadkinville Police Department patrol officers. He informed the Town Board that half of the monies would be obtained from the Police Department Federal Forfeiture Money. The remaining balance would be paid from already budgeted Capital Outlay Budget Items for equipment.

Commissioner Monta Davis-Oliver made the motion for Chief Parks to order the four (4) body cams. Commissioner Tony Hall seconded the motion and passed unanimously.

### **SWEEPSTAKES**

The Board of Commissioners discussed the sweepstakes business/privilege license. Joy Hutchens and Chief Tim Parks presented information. After a lengthy discussion, the Town Board agreed to table any decision until Chief Parks could present them with more information.

### **PROPERTY ANNEXATION**

The Board of Commissioners discussed the property annexation of Tennessee and Williams Road, Baity Tire and Marion Welborn (located on Service Road) properties. Commissioner Eddie Norman made a motion to annex the properties. Commissioner Kelly Oliver seconded the motion and passed unanimously.

### **PRESENTATION OF THE 2015-2016 BUDGET**




