1. CALL TO ORDER

The meeting was reconvened from June 1, 2015. Mayor Hubert Gregory called the meeting to order at 10:00 a.m.

2. INVOCATION

Mayor Gregory offered the invocation.

3. PUBLIC COMMENTS

No public comments were made.

4. ADOPTION OF FY 2015-2016 BUDGET ORDINANCE AND BUDGET

Commissioner Eddie Norman made a motion to accept the Fiscal Year 2015-2016 Budget Ordinance and the Fiscal Year 2015-16 Budget as presented by the Interim Town Manager Perry Williams. Commission Monta Davis-Oliver seconded the motion, and the motion passed unanimously.

Commissioner Eddie Norman made a motion to Adopt Resolution Directing Clerk to Investigate A Petition Received Under G.S. 160A-31. The motion was seconded by Commissioner Monta Davis-Oliver, and the motion passed unanimously.

5. CONSENT AGENDA (ITEMS 1-3) (1 motion needed to approve all)-Attachment #1

A motion to accept the Consent Agenda, as presented by the Town Manager, was made by Commissioner Eddie Norman. Commissioner Tony Hall seconded the motion, and the motion passed unanimously.

6. MANAGER'S COMMENTS

Interim Town Manager Perry Williams advised the Town Board that the contract with Republic Services of North Carolina was due for renewal for the Town's trash and recycling service. Several Commissioners express their concerns with the service and the need for improvements, especially with the placement of trash cans after trash disposal. The Town Board requested that Mr. Williams contact Mr. Ricky Craddock from Republic Services to attend the next board meeting on July 6, 2015 to address the trash removal schedule and any other concerns.

Commission Eddie Norman made a motion to authorize the Town Manager to sign the contract with Republic Services for the recycling and trash pickup providing that at the present time, the pickup days remain the same. Commissioner Betty Driver seconded the motion, and the motion passed unanimously.

7. COMMISSIONER COMMENTS

Commissioner Monta Davis-Oliver:

Thanked the employees at Town Hall for all they have done over the past few months with all the changes that have taken place. Commission Betty Driver agreed with Commissioner Davis-Oliver sentiments.

Commissioner Eddie Norman made a motion to appoint Mr. Perry Williams as permanent Town Manager for the Town of Yadkinville and Mrs. Shelia Weathers as permanent Town Clerk. Commissioner Betty Driver seconded the motion.

Mayor Hubert Gregory opened the floor for comments. After a brief discussion, it was the consensus of the Town Board to table the motion in order to allow Mr. Williams and Mrs. Weathers time to consider the proposition.

8. ADJOURNMENT

With no further business to be discussed, Commissioner Betty Driver moved that the meeting be adjourned. Commissioner Tony Hall seconded the motion and the motion was approved unanimously. The meeting adjourned at approximately 10:15 a.m.
