Tier 1 Façade Grant Application review

Planning Director Abigaile Pittman reviewed the Tier 1 Façade Grant Application for 105-107 Jackson Street, and reviewed the planning report provided in the agenda packet. Ms. Pittman stated that the proposed renovations for the awning and doors comply with the Façade Improvement Program guidelines; however, the vinyl material proposed for the two upper single double-hung windows with mullions, which are required to be wooden in compliance with the Secretary of the Interior's Standards for

Rehabilitation (SISR). There was a brief conversation with Assistant Manager Shelia Weathers and the Planning Board about the SISR requirements. Planning Director Abigaile Pittman also stated that she would need to see and approve the LED lighting the applicant proposes to use prior to installation. The staff recommended that the applicant's requested Tier 1 Major Façade Upfit be approved subject to the following conditions:

- 1. The material for the proposed two upped single double-hung windows shall be wood rather than vinyl; and
- 2. If the applicant is proposing an unfunded replacement of the existing 4x3 pane mullioned window on the first floor, then the window pattern of the two upper single double-hung windows should be consistent. That is, either both with mullions, or both without mullions. Either pattern would be appropriate for the building.
- 3. Staff approval of the LED lighting under the soffit prior to purchase and installation.

Mr. Virgil Dodson moved to approve the Tier 1 Façade Grant Application by Gray Garrison, subject to staff recommendations. Mr. R.J. Speaks seconded the motion and the motion passed unanimously.
