1. CALL TO ORDER

This Called Meeting of the Town Council was called to order by Mayor Hubert Gregory at 3:00 PM. on February 5, 2015.

2. INVOCATION

Mayor Gregory offered the invocation.

3. PUBLIC NOTICE OF CALLED MEETING

It was noted as follows:

1. Pursuant to North Carolina General Statute 143-318 (b) (2), a written notice of this meeting was posted on the principal bulletin board of the Town of Yadkinville in the Yadkinville Town Hall at 8:00 AM on February 3, 2015, period in excess of 48 hours before the time of the called meeting.

2. Pursuant to North Carolina General Statute 143-318 (b) (2), no newspaper, wire service, radio station, or television station has filed a written request for notice with the Clerk of the Town of Yadkinville or with some other person designated by the Town of Yadkinville.

3. Pursuant to North Carolina General Statute 143-318 (b) (2), no other person has filed a written request for notice with the Clerk of the Town of Yadkinville or with some other person designated by the Town of Yadkinville.

4. MOTION TO HOLD A CLOSED SESSION

Commissioner Eddie Norman then moved that the Town Council hold a closed session pursuant to North Carolina General Statute 143-318 (a) (6) for the purpose of considering the qualifications, competence, performance, character or fitness of an employees of the Town of Yadkinville.

Commissioner Eddie Norman's motion was seconded by Commissioner Kelly Oliver. Upon the motion being called for a vote, Commissioners Betty Driver, Monta Davis-Oliver, Kelly Oliver and Eddie Norman voted in the affirmative. No votes were cast in the negative.

Thereupon, at approximately 3:15 P.M. the Town Council went into closed session.

The Town Council resumed an open meeting at approximately 4:00 P.M.

5. TERMINATION OF THE EMPLOYMENT OF CHRISTOPHER ONG.

Commissioner Eddie Norman pointed out to the Town Council that pursuant to North Carolina General Statute 160A-147, the Town Manager serves at the pleasure of the Town Council. Commissioner Norman further pointed out that he believed the Town of Yadkinville should move in a different direction in regard to the management of the Town by its Town Manager.

Commissioner Eddie Norman moved that the Town Council terminate the employment of Town Manager Christopher Ong with the Town of Yadkinville effective February 9, 2015.

Commissioner Eddie Norman's motion was seconded by Commissioner Monta Davis-Oliver.

After discussion by the Mayor and the Council Members present, the motion was called for a vote. Commissioners Betty Driver, Monta Davis-Oliver, Kelly Oliver and Eddie Norman voted in the affirmative. No votes were cast in the negative.

6. TERMINATION OF THE EMPLOYMENT OF CARMEN HEADEN.

Commissioner Eddie Norman moved that the Town Council terminate the employment of Carmen Headen with the Town of Yadkinville effective February 9, 2015.

Commissioner Eddie Norman's motion was seconded by Commissioner Kelly Oliver.

After discussion by the Mayor and the Council Members present, the motion was called for a vote. Commissioners Betty Driver, Monta Davis-Oliver, Kelly Oliver and Eddie Norman voted in the affirmative. No votes were cast in the negative.

7. APPOINTMENT OF INTERIM TOWN MANAGER

Commissioner Betty Driver moved that Public Works Director Perry L. Williams be appointed Interim Town Manager effective February 9, 2015, to serve as Interim Town Manager until such time as a replacement Town Manager be appointed by the Town Council.

Commissioner Betty Driver's motion was seconded by Commissioner Monta Davis-Oliver.

After discussion by the Mayor and the Council Members present, the motion was called for a vote. Commissioners Betty Driver, Monta Davis-Oliver, Kelly Oliver and Eddie Norman voted in the affirmative. No votes were cast in the negative.

8. APPOINTMENT OF INTERIM TOWN CLERK

Commissioner Eddie Norman moved that Shelia B. Weathers, Public Works Department Office Manager, be appointed Interim Town Clerk effective February 9, 2015, to serve as Interim Town Clerk until such time as a replacement Town Clerk be appointed by the Town Council

Commissioner Eddie Norman's motion was seconded by Commissioner Betty Driver.

After discussion by the Mayor and the Council Members present, the motion was called for a vote. Commissioners Betty Driver, Monta Davis-Oliver, Kelly Oliver and Eddie Norman voted in the affirmative. No votes were cast in the negative.

9. ADJOURNMENT

Commissioner Eddie Norman moved that the Town Council adjourn this called meeting. Commissioner Norman's motion was seconded by Commissioner Betty Driver. The motion was called for a vote. Commissioners Betty Driver, Monta Davis-Oliver, Kelly Oliver and Eddie Norman voted in the affirmative. No votes were cast in the negative.
