1. CALL TO ORDER

3. PRESENTATION OF THE FINAL DRAFT COMPREHENSIVE PLAN – Presenter Ms. Erin Burris, Benchmark Planning

Ms. Erin Burris introduced herself and stated the purpose of the Comprehensive Plan to set forth the "blueprint" for the future of Yadkinville. The plan should guide the decisions of the Town Board for the new 2017-2018 Budget to improve and fulfill the Town's vision as stated in the Plan. The Vision Statement states, "The Town of Yadkinville has small-town charm with big-city benefits. The vibrant downtown awakens the senses with arts, entertainment, events, fine dining, and the Yadkin Valley wine region experience. The Town excels at supporting steady, managed growth with a solid, diverse economy and an ample supply of quality housing and health care services for its residents. The quality of life in Yadkinville is second to none for small towns in the region and is a comfortable place to live for the young, old, and everyone in between."

Ms. Burris went through the various stages of the Comprehensive Plan and gave an overview:

- <u>CHAPTER 1: INTRODUCTION</u> Purpose of the Plan, Town's Context, Demographic Profile, Housing Profile, Economic Profile, Existing Conditions Profile, and The Planning Process.
- <u>CHAPTER 2: PUBLIC INPUT</u> Public Survey Introduction, Public Survey Results and Public Workshop Results.
- <u>CHAPTER 3: VISION & GOALS</u> Vision, Goals, Community Identity and Character, Land Use and Growth Management, Downtown, Economic Development, Transportation, and Services and Infrastructure.
- <u>CHAPTER 4: IMPLEMENTATION STRATEGIES</u> Implementation Overview, Implementation Matrix and Resources.

Ms. Burris went through the final steps and goal of the adoption process. A public hearing will take place at the next Board of Commissioners meeting scheduled for Monday, June 5, 2017.

Members in attendance included the Planning Board, Long-Range Planning Committee, as well as, the public audience.

4. PUBLIC COMMENTS

Ms. Glenda Eldridge from the Yadkin Farmers Market addressed the Town Board and Ms. Burris. She noted she was the voice for the farmer's market and its future. Ms. Eldridge asked the Board to consider expansion of the park to include a large picnic area and be mindful of the farmer's market as they make decisions.
