Commissioner Tony Hall made a motion to approve the consent agenda item(s) for #1, to close out Fiscal Year 2022-2023. Commissioner Chris Matthews seconded the motion, and the motion passed unanimously. Vote:5/0

• Resolution No. 2023-04 to close out Capital Project "70" (Yadkinville Refuse Disposal).

Manager Koser explained that the auditors have already closed Capital Project 70, but the Town has not. He suggested adopting Resolution No. 2023-04 to close the accounts for that project.

Commissioner Chris Matthews made a motion to adopt Resolution No. 2023-04 to close Capital Project "70." Commissioner Scott Winebarger seconded the motion, and the motion passed unanimously. Vote: 5/0

### 5. APPROVAL OF THE FISCAL YEAR 2023-2024 BUDGET

During the presentation of the Fiscal Year 2023-2024 budget, Manager Koser stated that only minor adjustments were made and no funds would be transferred from General Fund to balance the budget. However, he did mention that funds would need to be transferred from the Water/Sewer Fund due to an increase in material costs.

Commissioner Chris Matthews made a motion to adopt the Fiscal Year 2023-2024 Town of Yadkinville Budget. Commissioner Richie Parker seconded the motion, and the motion passed unanimously.

#### 6. MANAGER'S REPORT

During the meeting, Manager Koser informed the Board about the STEP Plan, which is incorporated with our current Comprehensive Transportation Plan with NCDOT. The plan includes two trail projects: one from Northwood Church Road to Oak Street, and the other from Adams Street to South State Street. Mr. Koser asked for the Board's opinion on the projects. The Board agreed that greenways will stimulate economic growth.

Mr. Koser mentioned that Yadkin County is considering giving up zoning authority over three parcels on Service Road for the development of an RV park. If everything is approved, the Town will rezone the property and consider a Major Special Use Permit.

Manager Koser informed the Board that the CPNI workshop was productive. However, he has not received the final feedback yet. Mayor Norman mentioned that one suggestion was to hire an event planner.
