## 3. NEW BUSINESS

WAYFINDING SIGNAGE PRESENTATION (JASON EPLEY & MONICA GEHL):
Jason Epley introduced himself and Monica Gehl, from Benchmark Planning. Mr.
Epley gave a presentation on wayfinding signage. He noted the usage and importance of wayfinding signage. Mr. Epley stated the process for a wayfinding plan, with a completion date of late November or early December 2018. He presented examples of different sign designs. The Board discussed destinations appropriate for the signs, and where the signs should be located. Ms. Gehl introduced phase one of the Wayfinding Plans; adding welcome signs and wayfinding signage that highlights major destinations in the Yadkinville area. She presented pictures of potential welcome signs on South State Street, at the U.S. Highway 421 exit ramps. It was discussed that signs will be located at Lee Avenue, Willow Street, East Main Street, East Hemlock Avenue, and Tennessee Street. Mr. Epley discussed design elements for signs along with different options for imagery.
